### NOTHING TO FEAR BUT FEAR ITSELF!

In our lives as Masons and as men, fear is one of the greatest barriers we face. It whispers caution where courage is needed, and it builds walls where we are meant to step forward. But is fear not also a tool for reflection? A challenge urging us to move past inertia and toward action?

Consider the allegory of the rough ashlar:

An unpolished, imperfect stone brimming with potential. It is shaped through labour and refinement, not through avoidance of difficulty. Similarly, the obstacles we face and the risks we fear are the mallet and chisel of our lives, tools to carve out a better version of ourselves.

Freemasonry teaches us that every Brother must apply these tools to his own stone...

But the work begins by facing what we fear to undertake. Taking risks, whether in your personal pursuits,

professional ambitions, or even in the context of an Officer of the Craft, requires stepping beyond your comfort into the boundless possibility.

Just as we are reminded to seek light in darkness, so must we trust that stepping into the unknown leads us closer to understanding and fulfillment.

Why do we hesitate?


Perhaps it is the fear of failure or rejection, of disappointing others or ourselves. Yet our obligations call us to see past these fleeting doubts.

As Freemasons, we are builders: not merely of structures, but of lives of integrity, courage, and influence.


Every great endeavor begins with a single step: one where fear is acknowledged, understood, and ultimately overcome.











### **District Deputy Grand Master's Theme**

Is the District Deputy Grand Master automatically a Member of each Lodge in the District during his term of office?




The District Deputy Grand Master is authorized to preside, and only those with this authority are presented, received under the wands, accorded the Grand Honours and given the gavel.

Each Lodge in the District is required to send a copy of every Summons to the District Deputy; however he is not a Member of every Lodge in the District, and is certainly not entitled to vote or ballot. (See the Book of Constitution Sec. 96, 239 and 344).

Book of Constitution-Sec. 96-The District Deputy Grand Master shall have authority, unless the Grand Master or the Deputy Grand Master be present, to preside at any Lodge Meeting within his District and to direct the business thereof during his visit thereto.

Book of Constitution-Sec. 239-The Master shall cause the Secretary to send a copy of every Summons to the Members of the Lodge, the District Deputy Grand Master of the District in which the Lodge is situated, the Grand Secretary and the Grand Master.

Book of Constitution-Sec. 344-All Members of the Lodge present when the Ballot is taken must Ballot.





R.W. Bro. Rob Kiff reported on 27 February 2025 at the Peterborough District Masonic Association Meeting:

Thank you everyone for allowing me the opportunity to provide an update on our local District Project, now in its 2nd year.

The Skilled Trades Bursary for Graduating High School Trades Course students.

The local project, # 2469, has collected and accounted for \$25,561 since inception of the Project. This is the current figure taken directly from my local records ledger. R.W. Bro. Thomas Manning, current Director of the Masonic Foundation of Ontario, has relayed to us that Project #2469 has approximately \$15,800 on balance with them. This does not include the 25% top up, which will be calculated near the end of this Masonic year.

Therefore, in our current state, we'll have had approximately \$30,000 raised and "topped up" by the end of this May. We gave out \$10,000 last June, and discussions are already in play to pay out another ten \$1,000 bursaries this June. This will leave \$10,000 left to be able to give for a third and final round in June 2026.

Speaking with next year's prospective DDGM, James Dunn, he has indicated that he wants to have another way for his charity project. However, as he very much appreciates and understands the merits of this project, he is willing to see us run it in parallel to his.

Which means no fundraising for this Trades bursary next Masonic year.

- A) because we'll already have the funds, and
- B) so as not to compete with next year's project.

It is agreed that this is a steady way to disburse the remaining funds evenly over the three-year intent of the project. Naturally, this also ensures the funds donated to this specific cause will in fact go to the intended recipients.

To answer the question of just giving out \$20k this year, and forget spreading it out, both boards prefer to keep it manageable at ten students per year and, in fairness to all recipients, the bursary should be the same amount year over year.

June 21st is the scheduled awards ceremony at the Peterborough Temple. We would appreciate lots of attendance again this year, as we did last June. It was, and is, a great way to showcase a part of Masonry at work.

Both school boards are more than happy to accommodate us with this two-year plan, and we are working closely with them to facilitate the District Project through their respective OYAP plan.

Both board representatives have also asked that we pass along a warm "Thank You" from them to all the Brethren for their overwhelming generosity to this particular project. They know first-hand the tremendous impact it has had on our young apprentices' early start onward into their new life in the workforce!

To our current DDGM, R.W. Bro Bharat Maini, our prospect DDGM, W. Bro. James Dunn, and to all of you, the local Brethren, Thank you!

The enthusiastic support received since inception of this project is overwhelming.







## Ontario Masons

The winner of *The Lighthouse Trophy* for 2023 – 2024 was Otonabee Lodge No. 101. The trophy was presented to them on Wednesday, 16 October 2024, at their Lodge meeting.

**Dear Brethren** 

It is with great pleasure that we are able to invite you, and your families and friends, to the re-established Annual Event at King Solomon's Plot in Mount Pleasant Cemetery in Toronto.

Led by our Grand Master, and accompanied by the pipes, the Event is scheduled for Sunday the first of June, assembling at the gate on Yonge Street at 1:30 pm.

As a result of a lot of hard work by Members of Grand Lodge, the Toronto Masonic Service Guild and Bureau was just re-established this year, with many Toronto Lodges participating by electing representatives. This was the impetus for re-establishing the Annual Event that was led by our Grand Masters for over 120 years.

This impressive plot was established for the Toronto Welfare Board in 1884 by the generosity of Most Worshipful Brother John Ross Robertson. The magnificent twenty-five-foot Masonic column is surrounded by nearly three hundred grave plots which are reserved for Masons without financial resources. The Welfare Board included the many Toronto Lodges that comprised the Eleventh District of Grand Lodge, and was eventually renamed The Toronto Masonic Service Guild and Bureau. The burials have always been under their management.

The first parade to the plot was held on John Baptist Day, June 25, 1884. The eight hundred Brethren that paraded in regalia, led by M.W. Bro. Robertson, covered the two miles from the Masonic Building on Toronto Street to The Mount Pleasant Cemetery, just north of St. Clair. Most of it was through open countryside as then Toronto ended around Queens Park. Casa Loma, built nearly thirty years later in 1912, was on the hillside overlooking Toronto.

It is worth mentioning that one of the three chairs that M. W. Bro. Robertson had made from the beams of the Goose and Gridiron in London England is now in Casa Loma.

Bro. Robertson was the initiating force that created the Toronto Sick Kids Hospital, The Ontario Amateur Hockey League and much more of that at the Event. As a writer and publisher, he wrote up all of the speeches that were delivered at the original dedication. They were published in the *Freemason Magazine* of the Grand Lodge of England at that time.

We have them and those short speeches will be delivered by Brethren who have been cast. Our Grand Master is expecting support for the re-established Event from the Masonic Service Guild and Bureau Brethren, Members of Grand Lodge, many Brethren from the GTA and beyond, all who live within the length of the cable tow, along with their friends and families.

This will be a wonderful opportunity to let the world at large see what Freemasonry has been and still is.




"The large burial plot surrounding the striking Masonic monument was given to the Masonic Order in 1883 by one of its most celebrated Members, John Ross Robertson, founder of The Evening Telegram newspaper and himself a staunch member of the Craft.

The first burial in this plot occurred that same year. The monument, which had been designed by F. B. Gullett, another Member of the Craft, was unveiled by Robertson, a past Grand Master on June 24, 1893.

The ritual took place following a parade of 800 Masons from the Masonic Temple on Toronto Street through city streets to the cemetery. This is still an active burial plot."

#### **Lodge of Perfection**



This Body confers the Degrees from 4th to 14th. They exemplify the legend of the Master Mason Degree and the story of the building of King Solomon's Temple. These Degrees are designed to build on the teachings of the first Three Degrees given in the Craft Lodge. Unlike the Craft Lodge, Candidates are not required to do memory work

in any of the Scottish Rite Degrees.

Upon completion of the 14th degree, the new Scottish Rite member is entitled to wear the distinguished Scottish Rite ring that has retained its design for over 200 years. An inscription inside the ring reads: "Virtus Junxit Mors Non Separabit" that is to say, "Virtue has joined, death shall not separate", or "Whom virtue unites, death will not separate".

#### **Chapter Rose Croix**

After completion of the 14th Degree, the Masonic educational journey continues with the Degrees of the Rose Croix. The 15th and 16th Degrees related to the rebuilding of the Second Temple by Zerubbabel. The Second Temple Degrees portray the never-ending struggle against the adversaries of Truth and Light: a struggle that is still going on today. In these Degrees important moral and spiritual precepts of value to Masons of all ages are proclaimed.

The 17th Degree is an approach to, and the 18th Degree a recognition of, the religious ethics in universal terms: thus assisting in the building in our hearts of the Third Temple not made with hands. The 18th Degree culminates with the Degree of the Knight Rose Croix.

- 5. (If qualified by membership of a Lodge under the UGLE or under a Grand Lodge recognized by the UGLE) to attend all meetings of Quatuor Coronati Lodge; to participate personally in the discussion of papers after their delivery; and to dine with members of the Lodge after the meeting [see note on dining arrangements below].
- 6. To attend public presentations of papers delivered under the auspices of the Lodge, and to dine with members of the Lodge after the meeting [see note on dining arrangements below].
- 7. To submit to the Editor
  - (a) comments on papers published in AQC and
  - (b) questions relating to Freemasonry (to which considered answers will be given as speedily as possible
    - an important and rare service, drawing upon extensive scholarship).
- 8. To offer letters, reviews, information, photographs, and works of original research for possible publication within AQC;







#### Brethren,

Finally, the month of May has made it's arrival and that means that, even in the northern parts of our Jurisdiction, Spring is here. The buds and blooms are bursting open, the lakes and streams are alive and God's creation is green again. Not that Winter is a bad season, it's just too cold and snowy for my liking. Being a farmer means that Spring is the season for sowing seeds and watching new growth emerge. It's the season that starts the cycle all over again. All is well, Spring is here!

I'm going to start this Spring Communique with some good news and some bad news.

Let's do the bad news first. Many of you already know that we are in a terrible mess with our current Technology.



It's very unreliable, it's extremely costly, and it seems to be letting us down more and more as each day passes. We were promised the world when we first looked at this, and, as we now know, this technology was oversold and it was completely under delivered. It has been on my mind ever since I was Installed into the office that I now hold. We have finally found out that, in order to get this technology to where we need it to be, it will cost approximately another \$ 240,000.00 and there is no guarantee that it will stop there. On top of that incredible number, our yearly maintenance fee to keep this technology running is another \$ 80 000.00, which also rises about 3.5% per year. Let me say once more that in order to continue with our current technology, we would be on the hook for another \$ 320,000.00 this year. To me, as the head of this Grand Jurisdiction, this is completely unacceptable, unaffordable and undoable. Commonsense must prevail.

And now for the good news!

Our Grand Lodge is going in a different direction now, a more affordable direction that will give us what we need. When the Deputy Grand Master, the Grand Secretary and myself were attending the North American Conference of Grand Masters, we were given a private showing of a technology system that has already been designed, developed and tested, and it works. It's an existing system that has been developed by Masons for Masons. It makes sense, it is affordable and it works. I'm talking about the technology called *Grand View*. Our Management Committee has viewed a demonstration of it and gave their approval, the Audit and Finance Committee has given it's approval and I, as your Grand Master, have approved it. We are moving forward in this direction and it makes complete sense.

It's called *Grand View* and it is wholly owned by four Grand Lodges. It is a complete system and, as I said, it was built by Masons for Masons. It has everything that we need plus more. Everything that we were hoping to have in our current technology is already built into *Grand View*. This commonsense change in direction is a game changer. There is even stuff already developed that we were only thinking about, that we will now be implementing as well. *Grand View* is absolutely going to save us! Now, let me tell you the cost to move forward with this incredible initiative. It's \$ 1.05 USD per Member per year. And since our current unreliable technology cannot give us an accurate number of current Members, I am going to forecast approximately \$ 40,000.00 CDN, total !! Wow, are you kidding me, you say. Brethren, I am not kidding you. \$ 320,000.00 vs \$ 40,000.00 and this is the price for accuracy, for reliability and for success.

So now I come to the Members of our great Jurisdiction with this information. In July at the Annual Communication, we will be turning on the *Grand View* platform. The Seminars on Tuesday will have *Grand View* personnel giving instructions on it's capabilities, it's use and it's accuracy. *Grand View* is incredible, just wait and see for yourself. Not only will common sense prevail, but accountability is our positive path forward. We have to accept that we have spent an alarming amount of time and money on technology that just didn't make the grade, and now we must rethink our direction and move on. I believe that the solution to our woes is to embrace *Grand View*.

I intended to have so much information in my May Communique but I have used up my allotted space already. Brethren, stay tuned for more in the June Communique.

It is such an exciting time in the Masonic year as we are building up to our Grand Lodge Annual Communication in July, I hope that every Member who can make it to Toronto, does. Please plan on attending in July, take the time to sit in on the Seminars, so that you can take some Masonic Education back to your Districts and your Lodges. Come to the Grand Lodge meeting on the Wednesday and Thursday and see what is going on.

Come and attend the Grand Master's Banquet on Wednesday night for some fellowship, a great meal and to listen to our distinguished speaker, M.W. Bro. Andrew Beeler, from Nova Scotia. I can't wait to see you all in July at Grand Lodge!! Brethren, let us embrace the opportunities that lay before us with enthusiasm and dedication. Let us nurture the vibrancy of our Lodges, spread a blanket of positivity and inspiration wherever we travel, and work together as a team to build a bright future for Freemasonry in Ontario.

Remember, even on a cloudy day, the sun is still shining. Let us all be that shining light for our families, our Lodges, and ourselves. Carry and rub your shiny penny and hopefully you are as proud to be an Ontario Mason as I am.

will naturally follow.



#### Membership and Guest(s) Behaviour Annual Communication 2025

At prior in-person Annual Communications in 2019, 2022, 2023 and 2024 new policies regarding Membership and Guest behavior were implemented. A significant reduction in complaints was received. Also, we received many letters of commendation for the new policies asking that they be continued.

Therefore, the policies implemented in 2019 to manage behavior in Hospitality Suites will also be in force this year (2025).

- District, Lodge, and/or Member Hospitality Suites/Rooms are permitted only if registered as such with Mrs. Sandy Xu Papa (Sales Manager) at the Sheraton Parkway Toronto North Hotel. Email: sandyxupapa@sheratonparkway.com.
- The dispensing of alcohol at all times must be under the direct control of a Brother in possession of a Smart Serve Certification. Alcohol must not be carried in the hallways from one hospitality room to another or for any other reason.
- Admittance to a Hospitality Suite will only be gained by presentation of a valid Lodge dues card, which must be shown at the door prior to entry.

All other registered private suites/rooms must remain restricted to one-self and privately invited guest(s). They are not to be used for general hospitality purposes.

Smoking is not permitted in any area of the hotel, including stairwells. Large quantities of empty bottles must be removed from Hospitality Suites upon departure.

Incidents necessitating the attendance and direction of Hotel Security or Hotel Staff, for whatever reason, must be immediately complied with. Including, the ejection of all those present in the suite/room.

The registered rooms' occupants(s) are also subject to eviction from the hotel property. Previous incidents have necessitated members being permanently banned from the Hotel.

Voting for District Deputy Grand Masters and other elected Grand Lodge Officers in 2025 will once again take place electronically.

This letter will provide you with the details on how the elections and voting will be conducted and how you will be able to exercise your franchise.

#### This document may be shared and it will be posted on the Grand Lodge website.

There will be two separate and distinct electronic elections conducted again this year.

- The first election will be conducted in June of 2025 and will be for the election of all District Deputy Grand Masters.
- The second election will be conducted in July of 2025 and will be for the election of Grand Lodge Officers (including members of the Board of General Purposes).

#### It is strongly recommended that eligible voters register:

- Monday June 9, 2025 at 9:00 a.m. EDT Friday June 13, 2025 at 4:00 p.m.
- Successful registrations automatically register you for the July 2025 election of Grand Lodge Officers.

Note that the voting for the proposed Constitutional amendments will take place inperson only on the floor of Grand Lodge at the Annual Communication.

The Worshipful Master, Wardens and Past Masters are eligible to register.

Members and lodge Secretaries – please ensure member email addresses are up to date in the new system to ensure eligible voters receive Electronic Registration information, including the electronic registration links.

Registration links will also be posted on the Grand Lodge website.

For eligible voters who do not have access to a computer or mobile device, please see instructions at the end of this document.

# Election of the District Deputy Grand Masters June 2025:

#### Overview:

 The voting for DDGMs will take place electronically (from home or while travelling from any computer, tablet or smartphone).

- The election will run simultaneously in all 40 Districts at the same time.
- The election will be run under the auspices of Grand Lodge.
- The election will be conducted using software provided by Grand Lodge.
- Registration of every voter will be required to verify voter eligibility, acquire voter contact information (email) and for affiliated members of multiple lodges to choose the lodge they will vote under.
- Registration and voting will be conducted electronically only.
- Ballots will not allow for write in names in 2025 (i.e. no late nominations will be accepted).
- The election of the District Deputy Grand Master will be conducted independently from any District meetings held in the spring of 2025.

#### Nomination Process:

- Individual nomination forms must be submitted under the signature of the proposer and the nominee to the DDGM no later than May 30, 2025. The only nomination form accepted will be the fillable PDF form for 2025 provided by Grand Lodge.
- There will be no ability to add or remove candidate names after May 30, 2025.
- The DDGM is accountable for validating the eligibility of each nominee (according to the Constitution of Grand Lodge) and for ensuring the completeness of the nomination forms prior to submitting the District eligible candidates form to Grand Lodge.
- All District Deputy Grand Masters must complete the District eligible candidates form with the names of all eligible candidates nominated for the office of DDGM in their District and submit as the fillable PDF form provided by Grand Lodge.
- The District eligible candidates form AND the individual nomination forms must both be provided to Grand Lodge by June 01, 2025.

#### Election timelines:

- Voter registration will take place from Monday June 9, 2025 starting at 9:00 a.m. EDT until Friday June 13, 2025 at 4:00 p.m. EDT.
- Voting will take place on Monday June 16, 2025 starting at 9:00 a.m. EDT until Tuesday June 17, 2025 at 4:00 p.m. EDT.
- If required, a second ballot run-off election will be held on Tuesday June 17, 2025.
   See further details below.
- Results will be distributed to all voters as soon as reasonably possible.
- Once available, the DDGM may further announce and distribute the results to the lodges.

#### Ballot Preparation:

- There will be only one election for all DDGMs.
- Specific ballots will be created for each of the 40 Districts.
- A voter registered in a lodge in a District will see only the ballot applicable to the District for such lodge.
- Ballots will not allow for write-in names in 2025 (no last-minute nominations).
- Grand Lodge will appoint an Election Administrator and a Scrutineer.

The election administrator will confirm that a second ballot run-off election is required. The election administrator will see that all names are removed from the ballot for that District except for the two candidates that placed first and second on the original ballot. The election administrator will see that the names of all eligible voters registered for the first ballot are carried over to the second ballot run-off election (therefore no pre-registration for the second ballot run-off election is required). Eligible voters will receive an automated email advising him that there will be a second ballot run-off election.

Any second ballot run-off election will then proceed as follows:

- As soon as possible after the close of balloting on Tuesday June 17, 2025 at 4:00 p.m. EDT each voter who cast a ballot in the first election will receive an automated email advising him that there will be a second ballot run-off election. This same email will contain a link to use in casting a ballot in the run-off election.
- Voting in the second ballot run-off election will take place on Tuesday June 17, 2025 from the time an eligible voter receives his email notification of the second ballot run-off election until 8:00 p.m. EDT on Tuesday June 17, 2025.
- Voters will see only the ballot for their District with the two names of the candidates that placed first and second on the original ballot.
- Results will be distributed to all voters as soon as reasonably possible.
- Once available, the DDGM may further announce and distribute the results to the lodges.

#### Tie Breaking:

Should a tie vote result, the Grand Master will cast the deciding ballot.

## Election of Grand Lodge Officers (including members of the Board of General Purposes) July 2025:

#### Overview:

- The voting for Grand Lodge Officers (including members of the Board of General Purposes) will take place electronically (from home or while travelling from any computer, tablet or smartphone).
- The election will be run under the auspices of Grand Lodge.
- The election will be conducted using software provided by Grand Lodge.
- Registration of every voter will be required to verify voter eligibility and acquire voter contact information (email).
- Eligible voters who successfully registered in the June 2025 election for DDGMs will be automatically registered for the July 2025 election of Grand Lodge Officers.
- Registration and voting will be conducted electronically only.

- Ballots will not allow for write in names in 2025 (i.e. no late nominations will be accepted) except for the office of Grand Master and Deputy Grand Master as specified in the Constitution of Grand Lodge.
- Because every eligible voter will be enfranchised with electronic voting, the use
  of the proxy was eliminated in 2021.

#### Nomination Process:

- Candidates MUST submit nomination forms as per the current Constitution of Grand Lodge (including candidate information and photograph).
- The nomination process for Grand Lodge Officers remains the same as specified in the Constitution of Grand Lodge with a deadline of April 01, 2025.
- Final lists of candidates will be prepared and distributed as specified in the Constitution of Grand Lodge on or before April 30, 2025.

#### Election Process and timelines:

- Voter registration will take place from Monday July 7, 2025 starting at 9:00 a.m. EDT until Friday July 11, 2025 at 4:00 p.m. EDT.
- Voting will take place on Monday July 14, 2025 starting at 9:00 a.m. EDT until Tuesday July 15, 2025 at 4:00 p.m. EDT.
- If required, a second ballot run-off election will be held on Tuesday July 15 and Wednesday July 16, 2025. See further details below.
- Results will be announced at the Grand Lodge banquet on Wednesday evening July 16, 2025 and subsequently distributed to all voters as soon as reasonably possible.

#### Ballot Preparation:

- The ballots will list the nominees for each elected office in alphabetical order.
- Grand Lodge will appoint an Election Administrator and a Scrutineer.

#### Voter Registration:

Registration is required to:

- Obtain the voter contact information (email address):
- Validate the voter eligibility;
- Assign every eligible voter to the lodge/District in which he is an active member in good standing;
- Allow an affiliated member to select which lodge/District he wishes to vote in;
- Assign a unique voter ID;
- Distribute any election communications required; and
- Receive results of the election as soon as reasonably available.

Masters and Wardens must register in the lodge in which they hold such office:

- Officers as recorded in the ontariomasons.ca site as of very early June 2025 will vote in such office for the 2025 elections.
- Officers installed/invested in June 2025 that serve a full term of 12 months will remain recorded under such office for the 2026 elections.
- This allows officers to be eligible to vote once in any given full term of 12 months.
   The Secretary of the lodge must always ensure officers are up to date in the new system.
   Registration will require the voter to supply:

- His Email Address (not validated be very careful entering the email address);
- His Grand Lodge Certificate Number;
- His Last Name;
- His Given Names (not validated); and
- His Lodge Number.

Voters who successfully registered for the election of the DDGM will NOT be required to register a second time in order to vote for the Grand Lodge Officers.

Their prior registration will be automatically carried forward to the election of Grand Lodge Officers.

#### Do NOT unsubscribe to registration or voting emails:

- If you unsubscribe to all you will not receive your voting link.
- If you unsubscribe to notices you will not receive notice for next election (e.g. second ballot run-off or voting for Grand Lodge Officers).

#### Voting:

- Once successfully registered, each voter will be sent a unique voter ID link at the start of the voting period to the email address provided in the registration step.
- Voting will require the voter to click on the unique voter ID link in the ballot.
- Once the voter has clicked on the voter ID link he will be presented with his
  electronic ballot.
- Once the ballot has been completed the voter will submit the ballot.
- Once the voter has submitted his ballot he will not be able to vote again.

#### Run-off Election for Grand Lodge Officers:

A candidate for the office of Grand Master, Deputy Grand Master, Grand Treasurer or Grand Secretary must, in order to be elected, receive a majority of all votes cast. Therefore, if there are more than two candidates for an office there is a possibility that on the first ballot, one candidate may not receive a majority of all votes cast. If that is the case, a second ballot run-off election will be held as soon as possible.

The election administrator will confirm that a second ballot run-off election is required. The election administrator will see that all names are removed from the ballot for that Office except for the two candidates that placed first and second on the original ballot. The election administrator will see that the names of all eligible voters registered for the first ballot are carried over to the second ballot run-off election (therefore no pre-registration for the second ballot run-off election is required). Eligible voters will receive an automated email advising him that there will be a second ballot run-off election.

Any second ballot run-off election will then proceed as follows:

- As soon as possible after the close of balloting on Tuesday July 15, 2025 at 4:00 p.m. EDT each voter who cast a ballot in the first election will receive an automated email advising him that there will be a second ballot run-off election. This same email will contain a link to use in casting a ballot in the run-off election.
- Voting in the second ballot run-off election will take place on Tuesday July 15, 2025 from the time an eligible voter receives his email notification of the second ballot run-off election until 12:00 p.m. (noon) EDT on Wednesday July 16, 2025.
- Voters will see only the ballot for the specific Office(s) with the two names of the candidates that placed first and second on the original ballot for such office.
- Results will be announced at the Grand Lodge banquet on Wednesday evening July 16, 2025 and subsequently distributed to all voters as soon as reasonably possible.

Note that in all cases, spoiled or void ballots are counted in the total votes cast. Abstentions are not counted in the total votes cast.

#### Additional Details:

Eligible voters without computers or mobile devices:

Any member of Grand Lodge (Past Master, Master or Warden) who is eligible and wishes to vote in the election who does not have a computer or mobile device that can connect to the internet must notify his lodge Secretary.

- The lodge Secretary will then be responsible for registering that member during the registration period.
- During the registration process the lodge Secretary will supply his own (or lodge) email address for the brother in question.
- Once registration has been completed the election software will send the voter ID for the member in question to the email address provided by the lodge Secretary during registration.
- The lodge Secretary will then be responsible for ensuring that a laptop or mobile device is made available to the member so that he can log in and cast his ballot during the voting period, including for any second ballot run-off elections.
- Once the ballot has been cast for that member he will not be able to vote again.
- The above process will not affect the vote of the lodge Secretary.

## Grand Lodge of A.F. & A.M. of Canada in the Province of Ontario

#### Grand Master

#### CANDIDATE AND SUPPORTER BEHAVIOUR

Freemasonry is a gentlemanly pursuit. It is expected that certain standards of behaviour will be observed, both by candidates and by their supporters.

Election to office should be based solely upon merit and ability. It is not a popularity contest and any undue or improper promotion or solicitation of any kind will not be tolerated at any time for any ongoing or future election period. Without limiting the generality of this statement, the following activities are unacceptable:

- preparation and dissemination of lists or otherwise of any candidate or group of candidates who are deemed "acceptable" by any person, district or region.
- "checking off" of candidates on a list or otherwise and sharing it in any manner.
- mailing, e-mailing or otherwise disseminating any statement or material that in any way encourages support for any one candidate or group of candidates, including encouraging the recipient to vote for any such candidate(s).
- wearing of buttons, emblems or any other articles meant to identify or encourage support for any one candidate.
- using social media, or any other technology or platform, including personal ones, to in any way appear to promote, offer, or pledge support for any particular candidate(s), or encouraging anyone to vote for any particular candidate(s).
- posting pictures that do not include all attendees, or any other posting of any kind, on any platform, including any "like", that in any way appears to promote any particular candidate(s) for an office of which they are or may be seeking.
- solicitation or procurement of monies to assist a candidate and/or his supporters in seeking his election.

These guidelines apply equally to all candidates and their supporters.

Every brother who lets his name stand to serve you as a Grand Lodge Officer deserves your respect. If you are inviting a candidate to your meeting, please invite all candidates running for that office.

The Committee on Credentials have full authority to enforce these guidelines and such enforcement may include disqualification of the offending candidate.

#### What is the significance of the Northeast Corner?



Cornerstones are laid in the Northeast corner.

Entered Apprentices stand in the Northeast corner of the Lodge.

The point midway between the darkness of the North and the brilliance of the East was chosen by ancient builders as the point of beginning - a spot to mark a birth - the commencement of a new structure.

Obviously, he who stands in the darkness has no light; as obviously, he on whom falls the whole light of the brilliant East and its rising sun is not in darkness.

The point halfway between then, is a symbol of a beginning - the traveller has left the darkness and moved toward the light. Those who build have left the "darkness" in which there is no building, and progressed far enough towards the "light" to lay a foundation stone: - a place that, by its position, symbolizes movement away from blackness into the day.

The symbolism of the Northeast corner

in the Entered Apprentice Degree is taken from this ancient practice of laying the cornerstone in the Northeast corner.

He who stands there in the Lodge, "a just and upright Mason," is himself a cornerstone of the Lodge

which will be.

A Lodge is erected, not only by, but upon, her sons.

The Entered Apprentice of today is the veteran Mason and Lodge Member of tomorrow.









Also included in the May 2025 issue of *The Ontario Mason Magazine* was an article by V.W. Bro. Greg McKinnon, Grand Archivist:

# From the Grand Archives

This month's submission is the cover and first page of the six-page booklet entitled <u>Entered Apprenticed Freemason</u> published by the Grand Lodge of Canada in the Province of Ontario.

This booklet, printed in 1953 is the second printing of the document and was authorized by the Grand Master that year, M.W. Bro. Nelson Collins Hart, (born June 11th, 1888 and died December 7th, 1959). Hart served as Grand Master in the Masonic years 1951-1952 and 1952-1953.

The first printing of this explanatory text regarding the ritual of the First Degree occurred in 1948 under the authority of Grand Master, M.W. Bro. Thomas Hamilton Simpson (born January 8th, 1891 and died November 4th, 1969). He served as Grand Master in Masonic years 1947-1948 and 1948-49.

This useful item was presented to the newly-made Entered Apprentice Mason and was used to help explain what they had just experienced on their very special night. It is similar to the updated Entered Apprentice booklet (still yellow) that most Ontario Lodges give to their recently Initiated

**Entered Apprentices.** 

The booklet touches on the next steps in the journey, the Candidate's entrance into Lodge, the Temple and the Lodge, and the virtues discussed during the ritual. Although only six pages long, there is a lot of information to aid the newly-made Brother. It clearly states on the cover that "This Booklet should be handed to the ...".

This type of document supports the Grand Lodge's ritual, education, and mentoring (REM) work. It provides an explanation of key components of the ritual, it educates the new Member, and is an excellent mentoring opportunity.

The Grand Masters of the past realized the importance of sharing this information as much as our modern Grand Masters do.

#### THE FIRST STEP

To be presented to the Recipient of the

ENTERED APPRENTICE DEGREE

The Degree of Entered Apprenticed Mason has been conferred on you, and you have, therefore, taken the First Step in becoming a Freemason. You are now a member of your Mother Lodge, and of the Grand Lodge of Ancient, Free and Accepted Masons of Canada, in the Province of Ontario. You now have voting and other privileges and must assume the responsibilities involved in those duties.

You have received the Book of Constitution and the By-Laws of your Lodge. You should study them carefully in order that you may understand the organization of this Grand Jurisdiction. In the "Constitution" you will find certain portions of the ceremony in which you have participated. Why not study them, and perhaps even memorize the "Charge"?

Before you advance you must be familiar with the progress you have already made; you must memorize certain parts of the ceremony and the answers to certain questions. A minimum of twenty-eight days must elapse before you will be permitted to take the next step.

Perhaps you have been somewhat confused by the experiences through which you have passed and you may be amazed

It is interesting to note that the booklet uses the word "Apprenticed" when referring to the Mason.

However when referring to the Degree the more familiar word "Apprentice" is used.

This is a small thing but most Lodges use Apprentice for both.

Perhaps we should look at the new Mason as being "Apprenticed" to our Lodges and strive to train him in the craft such as an apprenticeship should offer.

Also included in the May 2025 issue of *The Ontario Mason* magazine was this article:

## A CONVENIENT ROOM ADJOINING THE LODGE

Before the Candidate is permitted entrance, the Steward asserts that he is properly prepared. But do we ever consider in what manner he is prepared? Although we do not often question if this preparation can include more than what is stipulated in the Work?

Can it embrace such areas as his mind, comfort, ease, and confidence? Do we converse with the Candidate beyond a few non-committal statements? We must impart a feeling of relaxation with the knowledge that he is well cared for and will suffer no embarrassment. Our preparation should proceed at an earlier time than the convenient room.


A Worshipful Master might consider asking a qualified Mason to remain with the Candidate from the time of his arrival at the Temple until he enters the convenient room. During this period, the Candidate could be assured that the ceremony in which he is about to take part is a solemn and dignified rite; and that there will not be hilarity nor any horseplay.


That although Masonic teachings are founded on the V.O.S.L., Masonry itself is not a religion, neither does it try or intend to take the place of religion. If the Candidate relaxes and concentrates on what he hears, many parts of Masonry will be unfolded to him. He will also come to understand that the Members talking to him have learnt their parts and he, in his turn, will have to commit to memory portions of the ceremony and the answers to a few questions.

He need not feel overawed by this as all Masons before him have done it and survived the event. In these few moments when we practice what we preach we may change a man, who is apprehensive about Masonry and may be a little reluctant, into a solid and strong advocate of the virtues of Masonry.

# THE MASONIC FOUNDATION OF ONTARIO INCREASES DISTRICT & LODGE TOP-UP TO 33%

The Masonic Foundation of Ontario (MFO) aims to broaden Masonic Charity in Ontario beyond the confines of the fraternity.

Over the years the Foundation, through the support of Masons across the province, has provided more than \$22 million in financial assistance for student bursaries, medical research, drug and substance abuse education, youth initiatives in Ontario, and various community projects.

These efforts have all been directed towards "the cause of good" and enhancing the lives of citizens.

To further enhance Masonic charity into the community, in 1973 the Foundation began supporting local projects sponsored by Lodges and Districts. Additionally, the Foundation introduced an incentive for Lodges and Districts to undertake worthy local projects by supplementing the funds raised locally by 10%, up to a maximum of \$1,000. In 2023, this percentage increased to 25% with no fixed maximum.

In the past year alone, with the support of The Masonic Foundation of Ontario, over 30 District and Lodge projects, collectively raised nearly \$500,000 for local charities. These projects have supported local hospitals and hospices, food banks, children's charities, and charities aiding individuals with disabilities, among others.

To further amplify the impact of local charitable endeavors, effective April 1, 2025, the Foundation's Board of Directors has decided to increase this supplement to 33% of the funds raised locally with a maximum top-up of \$25,000. This increased supplement will be applicable to all future payouts to District and Lodge projects, including those currently registered with the Foundation.

For Districts or Lodges interested in initiating a local charity project, the application process for a MFO project is straightforward:

- Complete a project registration form naming a qualified registered charity (available online) and obtain approval from the DDGM before submitting it to the MFO Office.
- Throughout the year, Districts and Lodges should send all donations and funds raised to the Foundation, which will track all received monies.
- The Foundation will issue income tax receipts to donors contributing to registered projects.
- Upon the project's conclusion, the Foundation will issue a cheque in the name of the charity for the amount raised locally, plus an additional 33% provided by the Foundation.

Sixty years ago, the Masonic Foundation of Ontario was established to extend Masonic Charity in Ontario beyond the boundaries of the fraternity. We earnestly encourage Districts, Lodges, and Members to participate in this initiative to promote the principles of Freemasonry within the community for the greater good and the overall benefit of society.



For Masons the forget-me-not has a different meaning than it does for non-Masons.


In early 1934, soon after Hitler's rise to power, it be came evident that Freemasonry was in danger.

In that same year, the "Grand Lodge of the Sun" (one of the pre-war German Grand Lodges, located in Bayreuth), realizing the grave dangers involved, adopted the little blue Forget-Me-Not flower as a substitute for the traditional square and compasses.

It was felt the flower would provide Brethren with an outward means of identification while lessening the risk of possible recognition in public by the Nazis, who were engaged in wholesale confiscation of all Masonic Lodge proper ties.

Freemasonry went undercover, and this delicate flower assumed its role as a symbol of Masonry surviving throughout the reign of darkness. The explanation is continued on here:

During the ensuing decade of Nazi power a little blue Forget-Me-Not flower worn in a Brother's lapel served as one method whereby Brethren could identify each other in public, and in cities and concentration camps throughout Europe.

The Forget-Me-Not distinguished the lapels of countless Brethren who staunchly refused to allow the symbolic Light of Masonry to be completely extinguished.

When the "Grand Lodge of the Sun" was reopened in Bayreuth in 1947, by Past Grand Master Beyer, a little pin in the shape of a Forget-Me-Not was officially adopted as the emblem of that first annual convention of the Brethren who had survived the bitter years of semi-darkness to rekindle the Masonic Light.

At the first Annual Convent of the new United Grand Lodge of Germany AF&AM (VGLvD), in 1948, the pin was adopted as an official Masonic emblem in honour of the thousands of valiant Brethren who carried on their Masonic work under adverse conditions.

The following year, each delegate to the Conference of Grand Masters in Washington, D.C., received one from Dr. Theodor Vogel, Grand Master of the VGLvD.

Thus did a simple flower blossom forth into a symbol of the fraternity, and become perhaps the most widely worn emblem among Freemasons in Germany; a pin presented ceremoniously to newly-made Masons in most of the Lodges of the American-Canadian Grand Lodge, AF&AM within the United Grand Lodges of Germany.

In the years since adoption, its significance world-wide has been attested to by the tens of thousands of Brethren who now display it with meaningful pride.




The following was written by the late M.W. Bro. Raymond S.J. Daniels, a good friend of mine, as one of his *Masonic Moments*.

# THE CANADIAN MAPLE LEAF FLAG FIFTIETH ANNIVERSARY



The Canadian Maple Leaf Flag was adopted by Parliament on December 16, 1964, officially proclaimed by Her Majesty Queen Elizabeth II, and inaugurated on February 15, 1965, now observed in Canada as National Flag Day.

The adoption of the distinctive design emerged after much heated debate, led by the Leader of the Opposition, the Right Honourable Bro. John George Diefenbaker.

Our distinguished Brother, the Honourable John Ross Matheson, at the time the Parliamentary Secretary to the Prime Minister, Lester B. Pearson, by adroit negotiations with the opposing parties, was instrumental in the final resolution of the debate. Bro. Matheson was also responsible for the creation of the Order of Canada.

Bro. Matheson was Initiated in Queen's Lodge No. 578, Kingston, in 1940 on the night before he was deployed with his regiment for active service in World War Two. He was the recipient of the William Mercer Wilson Medal for Meritorious Service, a 33rd Degree Scottish Rite Mason, and a Member of the Royal Order of Scotland. On November 13, 2010, Bro. Matheson was presented with the Long Service Award – 70 Years a Freemason, in a ceremony attended by the Speaker of the House, Members of both the Federal Parliament and the Ontario Legislature, together with a host of friends and family. Bro. Matheson died on 27 December 2013. A great Canadian, it can be truly said of him, that he "lived respected and died regretted".

The words from the Sacred Writings in the Book of Revelation, "The leaves of the tree were for the healing of the nations" were quoted to describe the distinctive design of the Maple Leaf Flag.

In a speech given to the Supreme Council of the Ancient and Accepted Scottish Rite, Bro. Matheson said: "Our symbolism must need affirm spiritual values. It conveys a message of noble expectations for humanity, of our Masonic hope for an even 'better country.' Each of us, like the Flag, represents Canada. This nation can be no worthier than what we imagine and will it to be."

When the late M.W. Bro. Donald H. Mumby was the Director of the R.C.M.P. Degree Team, this Charge to the Flag was given as part of the ceremony:

I present our Flag, our symbol of Unity and Sovereignty, Between bars of red on a field of white, It blazons forth in its full Autumnal glory.

The Canadian Maple Leaf Whose points represent the Provinces and Territories, Which comprise our great Dominion.

To Freemasons -

The red symbolizes the dauntless courage of our forefathers, which we strive to emulate,

The white, that blameless purity of life and conduct to which we aspire, And the points, the eleven knightly virtues,

of which Patriotism is the greatest, and to which we are ever dedicated,

And finally, it inspires in us a reverence to Him, to whom we fervently pray God Save the Queen, [before King Charles III] and heaven bless
The Maple Leaf Forever.

As Freemasons we are obligated to fulfill the duties of a good citizen. As loyal Canadians, the National Flag is displayed in every lodge room and outside most Masonic buildings throughout the jurisdiction, a symbol of national unity and pride.

It is important, however, in the Masonic context, to make a distinction between "nationalism" and "patriotism".

Nationalism, pushed to the extreme, results in conflict and war; Patriotism is loyalty and respect for one's native land.

The distinctive lapel pin of our jurisdiction is the Red Maple Leaf surmounted by the Square and Compasses in gold, signifying that the wearer is a proud Canadian and a proud Freemason.

So Mote It Be. Happy to Meet. Sorry to Part. Happy to Meet Again. **Bro. Bill Hodwitz, from Niagara B District, writes:** 

"A few years ago I put out a Masonic newsletter called "The District Light".
Recently I began another, aimed at the Brethren of my Lodge,
hoping to rekindle the interest of lapsed Members."

Here's one that Bro. Hodwitz posted on Saturday, 17 May 2025:

#### A MASONIC MOMENT:

#### THE TYLER'S SWORD

To Masonry the sword is an emblem of power and authority, never of blood or wounds or battle or death.



The modern tiler keeps off the cowan and eavesdropper by the simple process of refusing to admit those he does not know. If they still desire to enter the tiled door, they must either be vouched for or be examined by a committee. The Tyler's sword is the emblem of his authority, as the Gavel is the symbol of the authority possessed by the Master.

We are told that the sword "Admonishes us to be ever watchful and guarded in our words and actions, particularly before the enemies of Masonry, ever bearing in remembrance those truly Masonic virtues, silence and circumspection."

Properly no Tyler's sword is ever carried in a scabbard. Its symbolism requires it to be ever ready at hand to "keep off cowans and eavesdroppers".



#### **Eavesdroppers?**

There was a time when men did not divulge their Lodge Membership in Freemasonry, even to their sons. Until recently we were told that we should not solicit Members but we should wait for them to ask us about the Masonic Order.

Now we are encouraged to reveal our Membership and be open about what belonging has meant to us.

That can cause a problem.

The "eavesdropper" from without is no longer to be feared. Our lodge rooms are so built so that it is unlikely that anyone could listen to what goes on within.

The real "eavesdropper" is the innocent profane who is told more than he should hear by a too-enthusiastic Mason.

We want to be truthful but selective in what we say about the Lodge and our work within it. We want to present Masonry in a positive and realistic way while dispelling negative impressions.

Further issues of this Masonic Bulletin will consider this challenge.

This was followed up with a second posting on Sunday, 24 May:

#### A MASONIC MOMENT: WANDS

The use of wands in Freemasonry likely draws on older ceremonial and religious traditions where wands were tools of ritual power, authority, or transformation.

There are Biblical references to staffs or rods of power. For example, Aaron used his rod to show to Pharaoh God's power.



In royal or court ceremonies, a staff or sceptre denote rank and office.



In Freemasonry, wands hold symbolic and ceremonial significance, especially in the rituals and workings of Masonic Lodges.

Deacons (Junior and Senior) carry wands as symbols of their role in facilitating communication between the Worshipful Master and other Officers or Candidates.

The dove has long been a universal symbol of peace, innocence, and purity, and thus aligns with the pursuit of moral and spiritual harmony.



The Stewards also often carry wands, representing their duties related to preparing Candidates and managing Lodge refreshments. Hence, the symbol of the cornucopia dispensing items of food.



Without the wand, the Steward must square the Lodge as does everyone else but with the wand he has the freedom to move about while preparing the area for the coming Degree.

During Masonic rituals, wands are used in formal movements and gestures.

This emphasizes the symbolic nature of the ritual, underscoring themes like order, hierarchy, and guidance.

Like a shepherd's staff, it helps lead or direct.



The use of the wand indicates that the bearer is acting on behalf of higher Masonic authority.

In essence, Masonic wands are tools of ritual, symbolism, and structure — used to represent authority, guide participants, and reinforce the solemn nature of Lodge ceremonies.

Their use reflects the Masonic emphasis on tradition, symbolism, and the careful choreography of its rites.

#### <u> Where did the term "Lodge" come from?</u>

As with many things we can only speculate as to where the word "Lodge" derived.

Dictionaries say that it probably came from the buildings, or huts, where the craftsmen worked and lived.

Lodges of Masons are mentioned at York Minster in 1352, at Canterbury Cathedral in 1429, at the Church of St. Nicholas, Aberdeen, in 1483, and at St. Giles, Edinburgh, in 1429.

"Lodge" first referred to non-permanent bodies, but gradually reverted to fixed localities, such as Edinburgh in 1598





#### THE BEGINNING OF FREEMASONRY IN CANADA

In 1717, Col. Richard Phillips was appointed Governor of Nova Scotia and Placentia (Nfld.). The garrisons at Annapolis Royal, Canso and Placentia were under his command. He continued as Governor until 1749. During that time, he was mostly away from the area and left its control to Lieutenant Governors.

Col. Richard Phillips had a brother named Erasmus and he had a son by the same name. It seemed to be a military family and, by 1726, we see Ensign Erasmus Phillips (now age 21) under his uncle's command in the 40th Regiment at Annapolis Royal. By 1737, Erasmus was now a Major and in November of that year he was made a Mason in St. John's Lodge, Boston, Massachusetts.

In 1738, Provincial Grand Master, Robert Tomlinson, gave Phillips a "deputation" to establish a Lodge. A deputation means the right has been given but there is no Charter or Warrant issued. Erasmus then returned and formed the 5th Lodge to be founded under the Provincial Grand Lodge of Massachusetts and the 1st Lodge in Canada.

Phillips was the first Master of this Lodge, named Annapolis Royal Lodge F.&A.M. (The Grand Lodge of Massachusetts does not number their Lodges).

The formation of the Provincial Grand Lodge of Nova Scotia, as issued from Boston in 1738, was not legal, the reason being that one Provincial Grand Lodge is not authorized to form another. Only a Grand Lodge has that power, in this case the Grand Lodge of England. Today this would never happen but times were much different back then. Personally, I see nothing wrong with a formation such as this, as long as it is done in the right spirit.

Erasmus Phillips may have realized that he was not properly sanctioned for we see in 1757 he applied to the Antient Grand Lodge of England, to be made Provincial Grand Master for Nova Scotia.

This request was granted. Three years later Erasmus suddenly died from apoplexy, at the age of 55 years.

It is difficult to say whether Annapolis Royal Lodge was under a Military "traveling" warrant or not. If there was no local Lodge, then the military were allowed to take in civilians.

Although Annapolis Royal Lodge did have civilian Members, it was basically a Regimental Lodge and their histories are tied together. In April of 1775 the American Revolution broke out. It is understandable why, in November of the same year, the Brethren of Phillips Regiment re-Chartered the Lodge under the 2nd Grand Lodge of England (the Antients) to become Annapolis Royal Lodge Number 42.

The Regiment fought at Louisbourg, Quebec City, the American War of Independence and the West Indies.

The Lodge apparently became dormant before 1810, as in that year the regiment, now serving in Spain, applied to the Grand Lodge of Ireland for a "traveling warrant". It was granted bearing the number 204. Irish traveling warrants only had numbers and an actual name was never attached.

From 1767 to 1788, Masonry in Annapolis Royal was neglected. In 1788 they applied to the Provincial Grand Lodge of Nova Scotia (Antients) for a charter. There it sat for seven years and, in 1795, the request was granted and they became Annapolis Royal Lodge Number 25, A.F.&A.M.

They carried on for 32 years before dormancy once again set in.

We must not be too hard on our Brethren. Life in those days was a struggle in itself. This, along with the American Revolution, all took its toll.

In 1863 Annapolis Royal Lodge applied to the United Grand Lodge of England and received Charter Number 1047.

In 1866, the Grand Lodge of Nova Scotia was formed.

All but one English Lodge joined the Grand Lodge of Nova Scotia and, in 1869, a renumbering of the Lodges took place.

Annapolis Royal Lodge was given Number 33 and this remains so today.



They then describe their History ...

"The Grand Lodge of Scotland was founded in 1736, making it one of the oldest Masonic Grand Lodges in the world.

Our origins
are deeply rooted
in the rich history
and traditions
of Scottish Freemasonry,
which dates to
the early 15th century.



Over the centuries, we have grown and evolved, but our core values of brotherhood, charity, and integrity have remained steadfast.

"It is not clear exactly when Freemasonry began but it is widely accepted to have originated from the stonemason trade guilds of the Middle Ages, referred to as Incorporated Trades or Crafts. The term "incorporated" comes from the fact that these various craft organizations held Royal charters, or "Seals of Cause" which allowed them to work exclusively within the Royal Burghs in the Middle Ages.

The language and symbols used in Freemasonic rituals today come from these older craft bodies.

The earliest use of the term Freemason dates from around 1390 but referred purely to operative members. Prior to the formalization of Freemasonry as we know it however, Scotland was already beginning to see a shift during the 17th century where more and more non-operative members were joining the old trade institutions.

Throughout the 17th, 18th and 19th centuries in particular, the fraternity expanded across Europe and the Americas leading to the position today where you will find Lodges globally.

From our humble beginnings, we have expanded to include numerous Provincial Grand Lodges across Scotland and District Grand Lodges and Grand Superintendencies Overseas, each contributing to the vibrant tapestry of our organisation.

Our history is a testament to the enduring power of Freemasonry and its positive impact on individuals and communities."

#### An Original Perspective

The Grand Master of the Scottish Constitution bears the unique title Grand Master Mason, an office which has been held by distinguished members of Scottish society.

Unlike other regular Masonic jurisdictions, all Members, of whatever rank, are addressed simply as "*Brother*". The usual and more complex Masonic titles are used in Scotland, but attach to the office, not the individual. This differentiates Scottish Freemasonry from much of the other traditions and keeps to the true teaching of the Fraternity and being on the level.

Lodges under the Scottish Constitution are sovereign bodies in their own right, with a considerable degree of control over their own affairs. Many Lodges pre-existed Grand Lodge, all zealously guarding their traditions, and were permitted to retain their own procedures, regalia, and distinctive rituals.

Having accepted the principle of independence of old Lodges, it was impossible to deny Lodges founded after 1736 the same level of independence. Of course the rituals must contain the principal points of each Degree, but the scope for elaboration is considerable, with numerous interesting variations.

Since Scottish Lodges have the right to choose the colours of the Lodge regalia, meetings are very colourful, especially if visitors from other Lodges are present.

Today, Scottish Freemasonry continues to flourish and grow, offering a unique and original perspective on Freemasonry that has survived for over 400 years.


#### **Key Figures**

#### William St. Clair of Roslin



The first Grand Master Mason, elected in 1736, who played a pivotal role in the establishment of the Grand Lodge.

#### **Robert Burns**



The famous Scottish poet and Freemason, whose legacy continues to inspire Members around the world.

#### King George VI



Duke of York was Affiliated into Scottish Freemasonry on the 2nd of June 1936. The ceremony took place in the Masonic Hall in the heart of the village of Glamis.

On the 1st of December he was Installed as Scotland's Grand Master Mason in front of 2500 Freemasons in Edinburgh's Usher Halls. However, he gave up that role after being crowned King George VI just 10 days later.

These individuals, along with countless others, have helped to shape the Grand Lodge of Scotland into the respected and influential organization it is today. As a 32° Scottish Rite, I received the Summons for the Spring Assembly 2025 Moore Sovereign Consistory.

In it is a summary about:

#### THE TOWERS

The land on which the Scottish Rite stands was part of the Crown Grant of land to Caleb Reynolds U.E. on December 15, 1796. It was sold to Jean Baptiste Rousseaux, whose widow sold 500 acres in 1816 to James Mills and Peter Hess. James Mills settled on the 240 acres west of Queen Street and, in or about 1835, he built Hamilton's first brick house on the site. In July 1884, Mr. Mills' estate sold the property to George T. Tuckett, son of George E. Tuckett, who had founded the Tuckett Tobacco Company and who served as Mayor of Hamilton in 1896.

In 1892, George T. Tuckett retained local architect James Balfour to design a residence for him on the property. It was completed in 1895. This building is now the Scottish Rite Club. Because of the typical "Balfouresque" architecture, the building was named "THE TOWERS". The iron fence was built ten years later. It is similar to the fence which surrounds Buckingham Palace in London, England.

The oak dining table in the Coffee Room is the original table made to order for George T. Tuckett. The woodwork in the Club, oak, bird's-eye maple, birch and cherry, was made in the furniture factory of John Hoodless & Sons, Hamilton.


In 1920, a group of Scottish Rite leaders in Hamilton bought the property as a future home for the Scottish Rite in Hamilton. The cornerstone of the Cathedral was laid on May 31st, 1922, by M.W. Bro. W. N. Ponton, K.C., the Grand Master. The building was opened and dedicated on May 7th, 1923, by the Sovereign Grand Commander, Sir John M. Gibson, K.C. M.G.

On September 30, 2007, our Cathedral was dedicated to the honour and in the name of III. Bro. Norman E. Byrne, a Past Grand Master and Sovereign Grand Commander. A beautiful display case of his various regalia now adorns the entranceway to the Cathedral.

Title to the property is held by a corporation entitled "TOWERS INC.", the corporation being owned by the three Scottish Rite Bodies

which meet here.

Restraint.


Nuance.

A Mason may carry the plumb line







## THE SECRETARY

An effective and efficient Lodge Secretary plays a pivotal role in the success of any Lodge. It's not for everybody and not everyone should be a Secretary.

For those who aspire to this important office, there are some key skills and traits you need at your disposal, including communication, interpersonal, management, leadership, and technical. You also need the right personality that allows you to work with a variety of different people, personalities, and backgrounds.

All these must come from a variety of sources: naturally, with training, or with personal growth. You don't need to be an expert in any given area, but you do need to be aware of the role each one plays.

Having a working knowledge of each and the ability to keep learning are key success factors.





## **Carefully Filling the Position**

The Secretary position suddenly becomes vacant for a variety of reasons. In some instances, the Lodge may end up scrambling to try to fill the role, depending upon how the previous Secretary left the position.

It is strongly recommended that an Assistant Secretary be given serious consideration, as a backup to the Secretary. There is a measurable learning curve required for the Secretary position, and to be as proactive as possible, there needs to be a strategy in place to have a solid succession plan in place for this position, otherwise, disservice is being done to both the new Secretary and the Lodge.

These roles should not be filled with just anyone, but thoughtful and careful consideration should be the focus before filling the roles with someone who is qualified or can prepare and learn quickly.

#### **Skills and Traits**

The Secretary must wear many hats: manager, project manager, human resource advisor, administrator, communicator, and tactful diplomat. The Secretary is in the business of communication and interpersonal relationships and thus needs all the skills associated with those roles.

As these traits are required to be an effective Master, a Lodge should consider a Past Master to fill the role of Secretary, having had similar traits when they sat in the East. He will already be familiar with developing the monthly notice, Masonic protocol, Constitution and Regulations of Grand Lodge, creating a meeting agenda, et cetera. However, just because a man served as Master, doesn't guarantee he will serve well as a Secretary. The right man, with the right skills and the ability to quickly learn and apply new material, who may not be a Past Master, can quite nicely fill the position.

To assist in deciding if a person is in possession of the right skill set to be the Secretary, here is a list of some soft skills and traits to consider they should have or acquire:

## **Effective recording:**

Having the ability to take good notes and be able to read them a few days later is critical to your success. Comprehensive notes during a monthly meeting, without interrupting the flow of the meeting, is an imperative skill set.

### **Effective writing:**

In conjunction with effective recording, there will be the requirement to write a business letter when communicating officially with the Grand Lodge, a Lodge Member, or a Candidate for the Degrees. The creation of concise and complete Meeting Minutes and assisting with or, in some cases, writing the monthly meeting notice holistically.

## Sound listening skills:

One needs the ability to answer a question, resolve a conflict, or provide advice on protocol or process. Listen attentively, utilizing reflective listening, ensuring that there is a concise understanding of the subject before providing any qualitative answers. Sound listening skills will allow for a thorough understanding of issues or concerns, resulting in Members being more receptive to broaching subjects with the Officer.



## **Effective speaking:**

This is useful for those times when you must read a report or update the Master and Lodge with information from the District, Grand Lodge, or any other source.

## Patience:

Patience is a virtue and, for the Secretary, this could be considered the most essential skill set in their arsenal. The Secretary wears many hats and deals with many people within and outside the Lodge, and not all interactions will be pleasant in nature.

The Secretary needs to practice patiense if he wants to continue to work effectively in all his roles. Patience will have to come naturally; the Secretary will have to control his emotions, therefore, the more natural this skill set, the more effectively the Secretary will fill this role.

## **Accuracy and Attention to Detail**

"Know before you speak" should be the main mantra of the Secretary, as being an effective communicator is to gather the proper information, ensure the details are correct, and then disseminating the information to the Brethren. Incorrect and or insufficient information can be harmful, a nuisance, and an inefficient use of time.

This can result in requiring additional clarifications or corrections and, if this becomes the norm, then credibility and reputation can be compromised.

Take the time to be thorough the first time, reaping rich rewards at the end, keeping in mind the big picture, providing accurate detail without divulging too many secrets of the Craft.

## Time Management, Prioritization, and Organization

The Secretary must practise sound time management skills along with the ability to be organized and effectively prioritize work. As there is a steady stream of communication flowing to and from the Secretary's desk, whether it be of internal or external nature, the Secretary must be cognizant of the variety of deadlines required by their Lodge, the District, and the Grand Lodge, and administer themselves accordingly; tasks including general paperwork, applications for membership and affiliation, letters, emails, phone calls, text messages, invoices, cash receipts, candidate material, and awards, to mention a few.

In dealing with the above items, the Secretary needs a sound method to organize their work.

Without a sound system to effectively receive the information, properly process and distribute it to the correct recipients timely, and organize it, all with a sense of proper prioritization, the inexperienced Secretary can be easily overwhelmed.

Knowing this before assuming the Secretary role and preparing for it in advance will make life a lot easier for everyone.

## **Trust, Confidentiality, Judgement, and Discretion**

The Secretary is often the first point of contact for information and guidance, regardless of the circumstances, whether it be during difficult situations or pleasant situations. The Secretary is often the "go to" person for everyone in the Lodge.

As such, a level of trust must be developed where confidentiality and discretion are its cornerstones.
Once trust is established, people will be more candid and know they can confide in the Secretary with sensitive, possibly embarrassing information.



The Secretary must be able to maintain this level of trust and confidentiality, all the while balancing it with sound judgement and discretion, especially when someone's safety or the interest of the Lodge is at stake.

The Secretary must be able to use all the "soft skills" at his disposal and judge a given situation, maintain trust and confidentiality, and practise unbiased discretion to determine what next steps, if any, are necessary.

## **Software Application Proficiency and Online Skills**

The Secretary will need to have a working knowledge of word processing, spreadsheet creation and maintenance, and publishing. Microsoft Office and Mac Tools provide programs conducive for the Secretary to properly administer their role. However, the more standard the product, the better the chance that others will be able to communicate without software compatibility issues.

In some cases, the Lodge may have a website, which the Secretary will have to navigate through or administer as part of their role. With today's advanced technology, the Secretary will need to know how to navigate through this world to properly administer the role as effectively and efficiently as possible.

### **Relationship with the Worshipful Master**

It is vitally important that a strong and respectful relationship exists between the Worshipful Master and the Secretary.

It is also important that this relationship is reciprocal, as friction between these Officers manifests itself negatively to the Brethren in general and the Lodge specifically.

There must be a mutual respect between the two, continually fostered throughout the term, for the good of the Lodge. The Secretary must respect the Master's boundaries and authority, respecting the position, even if the relationship can be contentious at times. Resist any temptation, especially if the Secretary is a Past Master, to control the presiding Master.

The Master may conduct himself in a manner that may be perceived as non-traditional. The Secretary must respect the fact that he is not the Master. Instead, the Secretary can better serve the Lodge as a mentor to the presiding Worshipful Master and not as an obstacle to overcome.

Sound guidance and council, timely reminders, following the Master's preferred communication method (ex. Phone, email, text); proactive assistance, discretion, in addition to utilizing the skill set described in this article are beneficial to all.



### **Administration**

There are specific duties and responsibilities the Secretary must oversee, which are outlined in the Secretaries Guidebook from the Grand Lodge.

Some are mentioned above, such as scribing the Minutes of meetings; disseminating the monthly Summons to the Brethren; completing the semi-annual report required by the Grand Lodge in January and June, et cetera. It is highly recommended that the Guidebook be acquired for all Secretaries of any Lodge. Whether they be new to the role or seasoned, it is an excellent resource for any Secretary to keep them on track in their role.

## **Summary**

This is one of the most pivotal roles in any Lodge, if not the most pivotal role in the Lodge. While the Worshipful Master oversees the specific meetings and fraternal relations of the Lodge, the Secretary oversees the administration of the Lodge.

While the Master is a one year term (in most Lodges), the Secretary can be in the role for several years. Therefore, the Secretary is the main person in the Lodge who will liaise with the Grand Lodge on issues and or inquiries that the Lodge will bring forth. He is the person that all Lodge Brethren will communicate with on issues that they will have a concern having resolved or directed.



## A CONVENIENT ROOM ADJOINING THE LODGE

Q. Where were you first prepared to be made a Freemason?

A. In my heart

Q. Where next?

A. In a convenient room adjoining the Lodge.

How often do we find in our own jurisdiction that the convenient room adjoining the Lodge is just that? It can range from being nothing more than a utility cupboard, to a room that is used to store the banners and paraphernalia from other Masonic orders.

In some Lodges the convenient room is at least a small room, whilst in other it can be no more than a section of partition or a curtain that is drawn across a corner of the entrance hall-way.

However this approach to what constitutes a convenient room is not unique to this jurisdiction alone for Masonic author, Bro. Robert Lomas, in his book <u>Turning the Hiram Key</u>, describes his experiences of the convenient room at his Initiation as, "... On that chilly winter night my lack of proper clothing was bringing me out in goose bumps ... In the distance muffled conversations were audible; the sounds of different voices creeping under the closed door were overlaid with the rattle of cutlery coming up the stairs. I was alone, pondering the wisdom of seeking Masonic Initiation [as] ... I was standing in the ladies' toilet on the first floor of the Eaglecliffe Masonic Hall ..."

Hopefully we do not have many lodges in our jurisdiction that have to resort to the ladies' toilet for their convenient room. But it raises the question regarding the import of the question, where next? And do we take the answer to that question seriously enough, or is it treated in a purely perfunctory manner with no due relevance or meaning attached.

As most TFTEM readers would be well aware, the concept of the convenient room in many European and American jurisdictions is taken quite seriously with said room being referred to as "A Chamber of Reflection". These rooms are meant to be used as a time of quiet reflection to consider why a Brother has decided to join Freemasonry, and in some Lodges this very question requires a written answer that is then read out to the Lodge before the ceremony takes place.

A Chamber of Reflection may also contain various items designed to stimulate reflection, such as an hour-glass, skull, or a lit candle, with the phrase "know thyself" or the acronym V.I.T.R.I.O.L. written on the wall.

For these Lodges the convenient room is designed to be more than just a place to dress the Candidate, for it is not only meant to stimulate reflection but also to create the right mental state for the Initiation ceremony – to be properly prepared.

So, do we sell our Candidates short by offering them no more than a broom cupboard to mentally prepare themselves for the ceremony of initiation?


Our ritual states that, "... externally you were prepared in a peculiar manner in a convenient room adjoining the Lodge..."

Should that preparation at the Lodge prior to the ceremony of Initiation

be more meaningful?

Should all future newly-built or renovated Lodge Buildings include a real convenient room adjoining the Lodge – i.e., a Chamber of Reflection?





For a number of years, Bro. Francis Dryden sent me his monthly newsletter, *The Trestleboard*, from sunny Mexico. However, most unfortunately, it is no longer available.

Each issue of *The Trestleboard* newsletter included articles by Carl H. Claudy.

The Old Tiler Talks, first published in 1925, by Carl H. Claudy, is a series of short anecdotal stories told in the setting of a new Member asking an Old Tiler for his opinion on various Masonic topics.

These short articles are still very relevant, 100 years on, and hopefully provide some insight to new Members today.

Here's one entitled:

"I am much disappointed," announced the New Brother, sadly, sitting down beside the Old Tyler during refreshment.

"Disappointed in what?" asked the wielder of the sword.

"Why, Masonry in general, and this Lodge in particular," answered the New Brother. "Neither are what I thought they were."

"That's too bad," sympathized the Old Tyler. "Tell me about it."

- "My dad was a Mason. He told me how helpful Masonry was and how a Lodge stood back of a fellow, and how one Brother would go out of his way to help another, and, if you were in trouble, a Brother would help you out of it. I believed it. But I have been a Member here now for some time, and I have seen none of that."
  - "Been in trouble, son?" asked the Old Tyler.
  - "I suppose everyone has some troubles."
- "Have you been in any real trouble, in which you could have been aided by the Lodge had the Lodge known of it?"
  - "That isn't the question," answered the New Brother.
- "No, I agree it isn't. So I will ask you the real question," said the Old Tiler, and his lips lost their smile.


"How many Brothers have you helped since you have been a Member? How many shoulders have you slapped? How many men have you gone to and said, 'Jim, I know you are in trouble, count me in to help because we both belong to the same Lodge?"

"Why, how you talk!" replied the New Brother. "I hardly know anyone in the Lodge, yet. How would I know whether they were in trouble?"

"The same way they would know if you were in trouble, of course!" answered the Old Tyler.

"I am a old man and I have had a lot of trouble, most of which never happened. You complain that Masonry is a failure because you have not personally experienced its helping hand. You admit you haven't needed it. And you also admit you haven't held it out. Brotherhood means the relation between two Brothers, not the relation of one Brother to another and no comeback. If you can't be a Brother, how do you expect a man to be a Brother to you? You ask me how you would know if a Brother is in trouble.

How does anvone know?"



"Here are some stories I heard last week. Brother A, of this Lodge lost his wife two weeks ago. It was in the papers. Two Brothers of this Lodge sent their wives to his house to look after his children until he could make arrangements for a nurse."

"Another Brother of this Lodge failed in business. Lodge action wasn't necessary, but two bankers and a business man went to the poor failure and staked him, and put him on his feet."

"A Brother of this Lodge has a boy who is wild. Last week the boy went joy riding with too much hooch in him and smashed up a car which didn't belong to him. The owner wanted to put the boy in jail, where he belonged, but a Brother of this Lodge took the responsibility on himself, sent the boy to a farm during good behaviour, saved the father from a broken heart and maybe society from a criminal."

"The home of a Brother of this Lodge burned down last month. It wasn't insured. He had just paid for it. Ten Brothers of this Lodge financed his new house; he will pay a dollar a week for life, or something, but he had fraternal help."

"Three Brothers in the Lodge tonight are out of work, and with little money. Before they go away someone will see that they get a chance."

"But how do Brothers know other Brothers are in trouble? They don't get up in Lodge and tell it!"

"How did you expect people were going to come and help you if you didn't let them know you needed help?" countered the Old Tyler.

"Why, I just thought maybe someone would have enough interest in me to know ..."

"Have you had enough interest in your Brethren to know when they were in trouble?"

"I ... er ... why ..."

"You needn't answer. In every Lodge are the 'gimme's' and the 'lemme's'. The 'gimme's' are those who want things done, and the 'lemme's do them."

"In every Lodge are the 'have's' and the 'haven'ts'."

"It's up to the 'have's' to share with the 'haven'ts'."

"I take it you are naturally a 'have'.
You have money, clothes, a good position.
You are not in need of help from your Brother.
But some Brethren are in need of help from you.
It may be a dollar, advice, a word
to an influential friend, a loan, it may be

"If brotherhood is to mean what you hoped

some of the things I have told you about."

it won't be because you get it, but because you give it. A Masonic Lodge should never be an organization from which a man expects to get something. If everyone was disappointed because no one did anything, it would be a failure. It isn't a failure because most real Masons look for the chance to do something for some Brother who needs help."

"Some Brethren do a lot for idiotic new Brothers, just by talking to them!"

responded the New Brother remorsefully.

"Do you suppose you could slip a dollar to each of those three who haven't any and tell 'em you found it on the floor?"

"Could be," answered the Old Tyler.

"And please believe I don't think it's a failure and the only thing about it which is disappointing to me is myself."

"You see, I \*did\* manage to tell you!" answered the Old Tiler.




Bro. Carl Harry Claudy (1879 - 1957) was an American author, magazine writer, and journalist for the *New York Herald*. His association with Freemasonry began in 1908, when, at the age of 29, he was Raised a Master Mason in Harmony Lodge No. 17 in Washington, D.C. He served as its Master in 1932 and eventually served as Grand Master of Masons in the District of Columbia in 1943.

If you can believe it ... Bro. Carl Claudy wrote well over 400 of these *Old Tiler Talks* along with

many other Masonic books and pieces ... a very dedicated Mason and man.

His Masonic writing career began in earnest when he became associated with the Masonic Services Association in 1923, serving as Associated Editor of its magazine, *The Master Mason*, until 1943.

But prayer will lead us all to LOVE, And LOVE will show the PROOF, That Brotherhood will give us PEACE, And that's the honest TRUTH.



This illustration depicts the entry and progression of the fraternity.



## DID YOU KNOW ???



The Grand Lodge College of Freemasonry offers interesting Correspondence Courses on Masonic Education throughout this Jurisdiction which is comprised of nineteen different modules. Any Master Mason may take any module individually for \$10.00 each or they may wish to complete a course of study for a set fee. If a Brother takes an individual module today, and decides to complete a course of study later in time, he will be accredited with the module he has completed prior. In other words, he does not have to pay for or rewrite



what he has already completed in the past. There are four courses of study offered by the College of Freemasonry:

- 1. "The Masonic Arts and Sciences course".
- 2. The "Past Master's course".
- 3. The "Worshipful Master course"
- 4. The "District Secretary's course".

Any Brother looking to run for the office of D.D.G.M. or Grand Registrar is required to have in their possession a certificate of qualification from Grand Lodge. In July 2018 a constitutional change was approved by the membership, and Section 50 (b) now reads ... A candidate for office as District Deputy Grand Master or Grand Registrar must be in possession of a qualifying certificate as offered by our Grand Lodge, on or before June 15 of the year seeking office. (2018). A copy of the revised 2018 Book of Constitution is on the Grand Lodge website. It can be found under the Recent documents tab.

What this change means is that there are now two paths available to receive a qualifying certificate for this running for D.D.G.M. or Grand Registrar. One remains the Past Masters Course and the other is to participate in any number of the day-long enhanced D.D.G.M. Preparation workshops that are conducted around the jurisdiction.

For a Past Master that is looking to run for the Board of General Purposes, the certificate of qualification remains the same under Section 38 (b), and that is the "Past Master's Course" offered by the College of Freemasonry.

For those who wish to pay for the College course you can do so by cheque, please send it to W. Bro. George Warner, 4010 Chadburn Crescent, Mississauga, ON, L5L 3X2. For those who wish to pay via credit card, just fill in the application form and send it to <masonic.college "at"gmail.com>, and the Brother will be e-mailed payment instructions through PayPal (an account is not necessary). If any Brother has any questions, they may e-mail R.W. Bro. Rick Cadotte, FCF, Administrator, College of Freemasonry, <masonic.college "at"gmail.com>. You may also get information by going to the Grand Lodge Website. Sign in, click "Education", then "College of Freemasonry". We also have many electronic books and other resources here. Check it out!
